S^D NVT Summer 2025 info sheet

Students will attend a full day (8:30am-3:30pm) or half day (AM- 8:30am-11:30am or PM- 12:30pm-3:30pm) program for a minimal 30-day commitment. Make-up days are offered near the end of the summer. At this time, we are unable to offer the program in smaller pieces. However, in some cases, student needs may vary and we can try to find creative solutions so one summer program spot is made up of two different students. This will require approval and support from our directors. Our goal is to help serve as many students as possible with our current resources.

General Structure

The daily structure will allow students to attend school-based programs when they are available and then transition to group-based activities to work on therapeutic goals and with opportunities for social and emotional learning in the afternoon. The afternoons will take place at our South Burlington office. Behavior Analyst will provide oversight of day-to-day treatment, data collection and analysis, staff supervision and a progress report at the end of the program. The group-based learning with opportunities for social and emotional learning will be designed with consultation from a Special Educator.

When students do not attend school-based programs (either for certain days within the summer or for the duration of the summer program) we ask that all IEP goals typically addressed by school-based service providers are outlined and materials provided to our team to help with continuity. Special Education consultation will be available for all students.

Transportation from schools to our South Burlington office can be provided (release of liability), as well as transportation to community location for additional activities as part of the group-based afternoon program.

Specific logistics

Please meet with your Behavior Analyst to work out specific logistics for your team regarding the schedule, services, transportation, etc. Our goal is to be flexible enough to meet each student's needs while maintaining the structure that allows us to maximize the use of our resources and support. Thank you in advance for your understanding.

If schools are not physically available for students to work on their IEP goals in the mornings, we can provide a workstation within a group setting at our South Burlington office.

We ask schools to provide lunch for students receiving a full day of programming, we can be creative in how to get them from school cafeterias. If it is not possible for students to get lunch

for their school, we are able to provide lunch for an additional cost. Lunch will be scheduled from 11:35-12:15 at our South Burlington office.

If transportation to and from school is not available through typical school supports or by the family, SD may be able to accommodate this need on a case-by-case basis.

Summer program is Monday-Friday for the weeks of:

- July 7th (5 days), 14th (5 days), 21st, 28th (5 days), August 4th (5 days), and 11th (5 days)
- Full day at SD Associates (8:30-3:30) or half day (8:30-11:30, 12:30-3:30) program are available
- Make up days will be August 20th, 21st and 22nd
- Add on – School is Out for Summer June 30th, July 1st and July 2nd

For students attending school-based programs, we can provide a 7-hour day starting at the school start time.
